Quest Forum:

Jamie attended to discuss ice rental fees. The youth league will be discussing this at their September meeting. \$75 per hour may change. SYL is comparing HS hours to Youth League hours. We were questioning if we get reimbursed for providing our own coaches. Erin is looking into this.

Moving forward, we are only asking the HS players to play fall league. We will not ask 8th graders.

Bag #75 turned in?: unknown. Carrie will follow up.

Electronic tickets/cash: Bonduel is not doing electronic tickets. *Monique makes a motion to keep cash admission. Erin seconds. Motion passed.*

Ice fees: We will know more in September.

VP REPORT:

Family fees - meals, skate sharpening, etc.: We need to type up a general letter to clarify what this fee will cover. We need to show a breakdown so the families understand.

We need to go online to apply for Brewer and Packer tickets with our tax ID. We can apply for free items.
